Legislative Update



2018 Legislative Session – Follow Up

- 2018 Legislative Session
 - HB 411 Public records and Public Meetings/Firesafety Systems
 - Section 1 Security & Firesafety
 - Exempts firesafety systems plans from Public Records
 - Section 2 Security & Firesafety Systems
 - Exempts firesafety systems plans from public access
 - Section 3 General Exemptions from public meetings
 - Exempts firesafety systems plans from public meetings
 - Section 4 Applicability
 - Provides for retroactive application of the abovementioned exemptions



2018 Legislative Session – Follow Up

- 2018 Legislative Session
 - SB 7026 Public Safety
 - Section 31 Cost per Student Station
 - Provides that costs associated with physical security be excluded from the student station cost calculation if approved by the school safety specialist.
 - Cost for approved items must be below 2 percent per student station.
 - Section 44 Grant Program Funding Physical Security of Schools
 - Provide awards to fund costs associated with improving the physical security of school buildings as identified by a security risk assessment.



2018 Legislative Session - Follow Up

- 2018 Legislative Session
 - HB 7055 Education
 - Section 22 Patriotic Programs
 - Require each school board to adopt rules that require the state motto, "In God We trust" to be displayed in a conspicuous place in each school of the district and in each building used by the district school board.
 - Section 44 School District Construction Flexibility
 - Allows districts to exempt themselves from any provisions in the State Requirements for Educational Facilities (SREF code or manual) that limit the ability of a school to operate in a facility on the same basis as a charter school if the regional planning council determines there is sufficient shelter capacity within the district.



2019 Legislative Session

- SB 66 Lead Reducing Water Filters
 - Would require each school district to install water filters meeting certain requirements on water sources used for drinking, food preparation, or cooking for each school built before 1986.
- HB 169 Agriculture & Natural Resources
 - Would prohibit state funded contractors from commencing construction of certain structures without first conducting a sea level impact protection study (SLIP).



2019 Legislative Session

- SB 174 Panic Alarms in Public Schools
 - Would require each public school building on the campus of a public elementary school, middle school, or high school to be equipped with at least one panic alarm.
- SB 246 Public Construction
 - Would revise the amount of retainage that certain public entities and contractors may withhold from progress for any construction services contract.

 - Educational Facilities
 - Funding sources
 - Cost per student station
- SB 62 Students with Disabilities in Public Schools
 - May not place a student in seclusion
