

Fixed Capital Outlay (FCO)




Fixed Capital Outlay Office

- Sandra Sidwell, Director
 - Administer the FCO funds established by the Florida constitution and statutes
 - Make monthly cash disbursements
 - Prepare the Commissioner's Annual K-20 FCO Legislative Budget Request
 - Collect cost of construction reports, compute average costs and forward reports to the Auditor General

 - Service the state provides at no cost to the districts
 - Submit Plans
 - Digital format in Adobe PDF
 - Through TIBCO File Transfer Appliance
 - 208A
 - New Excel document will be in SREF
 - Plans Review Turnaround
 - 30 days, when fully staffed



Legislative Update



- Session begins
 - March 4th, 2025
- Session concludes
 - May 2nd, 2025





- SB 140/HB 123 Education
 - Amends s. 1002.33, F.S., to:
 - Clarify who may submit an application to convert a district school to a charter school
 - Grant the status of "job engine charter" to municipal charter schools that are in a school district that has received a grade below an "A" for five consecutive years
 - Requiring a school board to submit a 5-year plan to the Department of Education before occupying purchased or acquired real property
 - Prohibiting a school board from purchasing or acquiring real property if enrollment in the school district has declined in the preceding 5-year period

FLORIDA DEPARTMENT OF

- SB 140/HB 123 Education (Continued)
 - Allows state grants and capital improvement fees to be used for construction, debt service, maintenance, and operation of such dormitories
 - Requires school districts to:
 - Dispose of real property deemed by the State Board of Education to be a surplus if a decline of enrollment has occurred in the preceding five-year period; and
 - Making the surplus property available to teachers, first responders or military service members as affordable housing, or making the facility available to charter schools or local governments for recreational usage



- SB 62/HB 143 Resilient Buildings
 - Defining the term "resilient building"
 - Specifying that owners of resilient buildings are eligible to receive a specified tax credit
 - Requiring building owners to file a specified application with the Department of Environmental Protection by a specified date to claim such tax credit
 - Creating the Florida Resilient Building Advisory Council adjunct to the Department of Environmental Protection, etc.
 - Effective July 1, 2025



Lead Testing Program

- Voluntary School and Child Care Lead Testing and Reduction Grant Program
 - This program was put in place to sample drinking water in School and Child Care Facilities to determine if there are any potential problems with a lead exceedance in the drinking water. The testing and retesting procedures are free.
